April 18, 2022

**Happy Earth Week!** This is Akin Gump's <u>weekly policy newsletter</u> on all things **climate change**. Below are the major federal climate policy headlines of the past week:

- Interior Department Will Resume Oil and Gas Drilling on Public Lands
  On Friday, April 15<sup>th</sup>, the U.S. Department of the Interior announced that the Bureau
  of Land Management (BLM) will publish notices for reformed onshore oil and gas
  lease sales following an injunction from the Western District of Louisiana. Today,
  the BLM will issue its final environmental assessments and sale notices for the
  upcoming oil and gas lease sales. The BLM plans to auction off 145,000 acres of
  public lands in nine states for new drilling, marking the first fossil fuel leases on
  public lands of the Biden administration.
  - Biden Administration Announces New Climate Commitments at Our Ocean Conference

On Wednesday, April 13<sup>th</sup>, Special Presidential Envoy for Climate John Kerry led a U.S. delegation to the <u>Our Ocean Conference</u> in Palau. At the conference, Special Envoy Kerry remarked that the United States intended to make <u>100 commitments</u> <u>worth \$2.7 billion</u> at the two-day event. Further climate commitments are expected to be made this week as President Biden visits Seattle for an <u>Earth Week</u> event.
