## Treasury Tribal Advisory Committee Meeting Set for September 18, 2019

August 21, 2019

On Thursday, August 22, the Department of the Treasury will publish a notice in the [Federal Register](#) announcing that the Treasury Tribal Advisory Committee (TTAC) will meet on Wednesday, September 18, from 9:00 a.m.–4:30 p.m. (Eastern Time) in Washington, D.C., at the Treasury Building (Cash Room-2121), 1500 Pennsylvania Avenue NW. The meeting is open to the public.

Registration: Interested attendees must register online or by telephone no later than 5:00 p.m. (Eastern Time) on Tuesday, September 10. Interested attendees should register soon because the meeting will be held in a secure building and individuals must be cleared in order to enter the building. In addition, the TTAC will provide updates on priority issues, read any public and tribal comments submitted and take other actions necessary to fulfill the TTAC's mandate.
