FALSE CLAIMS ACT ALERT

LEGISLATIVE UPDATE



Last month's client alert described a significant Senate bill seeking to expand the scope of the False Claims Act (FCA) and curtail the defenses under the statute. This bill, known as the False Claims Act Corrections Act of 2007, has been referred to the Judiciary Committee, where no further action has been taken.

Although the bill's co-sponsor Senator Chuck Grassley (R-IA) stated that Congressman Howard Berman (D-CA) would introduce companion legislation in the House in mid-September, no such bill has been introduced. A far more limited bill known as the Whistleblower Recovery Act of 2007 was introduced by Congressman Mark Udall (D-Col.) on July 25, 2007, and would have the effect of overturning the Supreme Court's decision in the *Rockwell* case concerning the public disclosure provision of the FCA, but would not have the potentially far-reaching effect of the pending Senate bill. The House bill has been referred to the House Subcommittee on Courts, the Internet, and Intellectual Property, where no further action has been taken.

We will continue to monitor all FCA-related legislation closely and will provide periodic updates on the status of pending legislative efforts.
