## ENVIRONMENTAL ALERT – UPDATE

### A COMING WAVE OF ENVIRONMENTAL CASES?

**PLEASE JOIN AN AKIN GUMP CONFERENCE CALL ON FRIDAY,  
JANUARY 12 AT 2:00 P.M. ET**



As predicted in our Environmental Alert dated January 5, 2007, the Supreme Court granted cert in *EPA v. Defenders of Wildlife*, No. 06-549, consolidated with *National Association of Homebuilders v. Defenders of Wildlife*, No. 06-340, the first in a series of environmental cases expected to be considered by the Court this month. The petitioners sought review on whether federal agencies must comply with the Endangered Species Act when implementing other federal statutes. The Court also directed the parties to brief an additional question: “Whether the court of appeals correctly held that the Environmental Protection Agency’s decision to transfer pollution permitting authority to Arizona under the Clean Water Act, see 33 U.S.C. §1342(b), was arbitrary and capricious because it was based on inconsistent interpretations of Section 7(a)(2) of the Endangered Species Act of 1973, 16 U.S.C. §1536(a)(2); and, if so, whether the court of appeals should have remanded to the Environmental Protection Agency for further proceedings without ruling on the interpretation of Section 7(a)(2).”

During a conference call on Friday, January 12, 2007, at 2:00 p.m. ET, Akin Gump attorneys and others will be discussing this and several other important environmental cases on which the Court is expected to act soon. We intend to summarize the issues involved in these cases, the prospects that certiorari will be granted and issues on which interested parties may wish to consider filing amicus briefs. We also will answer any questions participants may have. Duane Desiderio, lead counsel for the National Association of Home Builders, will also participate in the call. The call is expected to last approximately one hour. We hope you will be able to join in what we expect to be an informative conference call.
