# 2017 Pro Bono Scholars Program



## Dallas | Houston | Los Angeles | New York | Washington, D.C.

The Akin Gump Summer Pro Bono Scholars Program, started in 2008, provides top first year law students interested in law firm practice the opportunity to develop an early expertise in public interest law. The skills acquired during this program build a foundation for pro bono work and billable practice that will serve participants throughout their careers. The program spans two summers, with the Pro Bono Scholars working both at the firm and at a public interest organization during the first summer (as rising 2Ls). The next (rising third year) summer, the Pro Bono Scholars join the firm as participants in the firm's general summer associate program.

The Pro Bono Scholars Program identifies and develops rising stars for Akin Gump.

FIRST SUMMER: Following the first year of law school the Pro Bono Scholars first spend four weeks with the firm working on pro bono matters; receiving substantive assignments and training in areas in which the firm focuses its pro bono practice. After the time at the firm, the Pro Bono Scholars spend at least seven weeks at a public interest organization. In past years, the firm has placed Pro Bono Scholars directly with organizations with which the firm works, while others have obtained their public interest positions independently.

**SECOND SUMMER:** During their second summer at the firm, Pro Bono Scholars join Akin Gump's Summer Associate Program for rising third-year law students in their selected offices. The summer program includes a workload of commercial assignments, as well as pro bono opportunities. Like all other summer associates, after completing their second summer at Akin Gump, the Pro Bono Scholars are eligible for consideration for an offer of employment to join the firm as an associate in one of the firm's commercial practices following their law school graduation. Twenty-two former Pro Bono Scholars are now associates at Akin Gump.

**COMMITMENT:** The firm expects Pro Bono Scholars to return for a second summer (following the second year of law school) to gain experience in Akin Gump's commercial practice. Accordingly, Pro Bono Scholars will be exempted from the on-campus interview process during fall of their second year. In the event that the Pro Bono Scholar's performance does not meet the firm's standards, the firm may decline to ask the student to return for the second summer, or may decline to make an offer of future employment as an associate.

#### **QUALIFICATIONS**

Open to exceptional law students completing their first year of law school in 2017 and who expect to graduate from law school in late 2018 or by summer 2019. Applicants must have all the qualifications expected of a summer associate, including a strong academic background, demonstrated leadership qualities, and a commitment to developing into a successful law firm associate.

## **COMPENSATION**

Pro Bono Scholars are paid the summer associate salary while employed by the firm and receive a stipend totaling \$17,000 for their time spent working at a public interest organization. The Pro Bono Scholars receive the first half of the stipend (\$8,500) when they begin work at the public interest organization. The second half of the stipend (\$8,500) is paid upon the Pro Bono Scholars honoring the commitment to return to the firm as a summer associate following their second year of law school.

## **APPLICATIONS**

First-year law students interested in this program must submit an application in order to be considered. The firm will accept applications between January 3, 2017 and February 13, 2017. The application should include a resume, transcript (uncertified is acceptable) and writing sample. In addition, each candidate is required to submit a short statement (no more than 500 words) describing his or her interest in having a career at Akin Gump and making pro bono a part of his or her practice.

You will need to upload the above listed required documents at the end of the application process. The firm recognizes that first semester grades at some law schools are not released until early February; accordingly, we will accept applications without the transcript, to be supplemented once grades are released. Applicants will receive instructions as to how to submit their transcript upon receipt of the other application materials.

Candidates may apply to, and be considered by, only one Akin Gump office. The firm will only consider applications that contain all of the requested documents and offers will not be extended before the firm has received the applicant's full transcript. Decisions are made on a rolling basis and we expect the selection of the 2017 Pro Bono Scholars to be completed by early March.

## Ali Boyd | University of Michigan Law School 2018 — Pro Bono Institute, Washington, DC

At the start of my 1L year, I would have never thought that my summer job would allow me to both feel like I'm making a positive difference in our world and provide me with an introduction to life at a big law firm.
